

ORDINANCE 2019-08

AN ORDINANCE OF THE BOROUGH OF BAY HEAD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SECTION 195-4 OF THE BOROUGH CODE ENTITLED “SEWER USAGE FEES TO INCREASE THE SEWER USAGE FEES IN THE BOROUGH OF BAY HEAD, OCEAN COUNTY, NEW JERSEY.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council the Borough of Bay Head, County of Ocean, State of New Jersey, as follows:

SECTION 1. The Municipal Code of the Borough of Bay Head is hereby amended and supplemented so as to increase the sewer usage fees for years 2019 and 2020. Section 195-4 entitled “Sewer usage fees” shall read in its entirety as follows:

§ 195-4. Sewer usage fees.

A. The following annual fees, charges and rates are imposed for use of the sanitary sewer system:

1. Single family dwelling with up to five (5) outlet fixtures	\$419.00
Each outlet fixture in excess of five (5)	16.00
2. Apartment, in any zone, with up to five (5) outlet fixtures	419.00
Each outlet fixture in excess of five (5)	16.00

10. Marinas with one apartment plus \$105.00 for each additional apartment	547.00
11. Marina	450.00
12. Garbage disposal units;	
Residential, per disposal unit	129.00
Commercial and other, per disposal unit	386.00
13. Railroad companies, with up to five (5) fixtures	419.00
Each outlet fixture in excess of five (5)	16.00
B. The annual fees, charges and rates in A above shall be effective as of January 1 st , 2019 for calendar year 2019.	
C. The following annual fees, charges and rates are imposed for use of the sanitary sewer system:	
1. Single family dwelling with up to five (5) outlet fixtures	\$440.00
Each outlet fixture in excess of five (5)	17.00
2. Apartment, in any zone, with up to five (5) outlet fixtures	440.00
Each outlet fixture in excess of five (5)	17.00
3. Hotels, rooming houses, lodging houses with up to five (5) outlet fixtures	609.00
Each outlet fixture in excess of five (5)	17.00
4. Dining establishments, defined as lunchroom, soda fountains, snack bars, diners, restaurants, with up to five (5) outlet fixtures	440.00
Each outlet fixture in excess of five (5)	17.00
5. Taverns and bars, with up to five (5) outlet fixtures	609.00
Each outlet fixture in excess of five (5)	17.00
6. Church buildings with up to five (5) outlet fixtures	440.00

7. Laundromats or laundrettes, base charge plus \$27.00 additional for each washing machine	440.00

9. Yacht clubs, base charge plus \$12.00 for each outlet fixture	777.00
10. Marinas with one apartment plus \$110.00 for each additional apartment	574.00
11. Marina	473.00
12. Garbage disposal units;

Commercial and other, per disposal unit	405.00
13. Railroad companies, with up to five (5) fixtures	440.00
Each outlet fixture in excess of five (5)	17.00

D. The above annual fees, charges and rates in C above shall be effective as of January 1st, 2020.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law
