

**BOROUGH OF BAY HEAD**

**ORDINANCE 2022-14**

**AN ORDINANCE OF THE BOROUGH OF BAY HEAD, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 147 OF THE BOROUGH CODE OF THE BOROUGH OF BAY HEAD, ENTITLED “LAND USE”**

**NOW, THEREFORE, BE IT ORDAINED**, by the governing body of the Borough of Bay Head, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** The Borough Code of the Borough of Bay Head is hereby amended and supplemented so as to amend Chapter 147, entitled “Land Use” so as to amend §147-6 entitled “General provisions,” so as to add a new subsection Q. which shall read as follows:

**Q.** Dumpsters and temporary storage.

- (1) Dumpsters are required for all new construction and additions. A dumpster permit for up to one year per location shall be required for all dumpster in accordance with the fees set forth in Article XVI of this Chapter.
- (2) Temporary storage containers or short-term dumpsters are permitted for up to seven days. A temporary container permit for a temporary storage container or dumpster is required. The fee is set forth in Article XVI of this Chapter.

**SECTION 2.** The Borough Code of the Borough of Bay Head is hereby amended and supplemented so as to amend Chapter 147, entitled “Land Use” so as to create Article XVI which shall be entitled “Zoning Fees”, and which shall read as follows:

§147-74. The fees for zoning permits shall be as follows:

**SECTION 3.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 5.** This ordinance shall take effect after second reading and publication as required by law.
