ORDINANCE NO. 2024-02

**AN ORDINANCE OF THE BOROUGH OF BAY HEAD,
COUNTY OF OCEAN, STATE OF NEW JERSEY, TO
AMEND CHAPTER 21 ENTITLED “ENVIRONMENTAL
COMMISSION,” SECTION 21-4 ENTITLED “TERMS;
VACANCIES” OF THE MUNICIPAL CODE**

WHEREAS, the Borough of Bay Head (the “Borough”) is a municipal corporation organized and operating under the laws of the State of New Jersey; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the Borough Council of the Borough are authorized to enact and amend ordinances as deemed necessary for the preservation of public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon by the Borough by law.

NOW, THEREFORE, BE IT ORDAINED, by the Governing Body of the Borough of Bay Head, County of Ocean, State of New Jersey that the Code of the Borough of Bay Head is hereby amended, revised and/or supplemented as follows:

SECTION 1. The Municipal Code of the Borough of Bay Head is hereby amended, revised and supplemented so as to amend Chapter 21 entitled “Environmental Commission,” Section 21-4, “Terms; Vacancies,” so as to amend §21-4 in its entirety as follows:

§163-2 Terms; vacancies.

The Commissioners shall be appointed for a term of one year. The current Commissioners shall serve until their term expires, and their successors shall be appointed for a term of one year and until the appointment and qualification of their successors. A vacancy on the Commission occurring otherwise than by expiration of a term shall

be filled for the unexpired term in the same manner as an original appointment.

SECTION 2. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed, but only to the extent of such inconsistency.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.


SECTION 4. The ordinance shall be published at least once in an official newspaper of the Borough of Bay Head at least ten (10) days prior to the time fixed for consideration of the final passage of the ordinance.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.
