

BAY HEAD BOROUGH

ORDINANCE NO. 2024-04

AN ORDINANCE OF THE BOROUGH OF BAY HEAD, COUNTY OF OCEAN, STATE OF NEW JERSEY, TO ADD CHAPTER 82, PART II GENERAL LEGISLATION TO BAY HEAD BOROUGH CODE, WHICH WILL BE ENTITLED “RULES, REGULATION AND FEES FOR MUNICIPAL TENNIS COURTS”.

WHEREAS, the Borough of Bay Head (the “Borough”) is a municipal corporation organized and operating under the laws of the State of New Jersey; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the Borough Council of the Borough are authorized to enact and amend ordinances as deemed necessary for the preservation of public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon by the Borough by law.

NOW, THEREFORE, BE IT ORDAINED, by the Governing Body of the Borough of Bay Head, County of Ocean, State of New Jersey that the Code of the Borough of Bay Head is hereby amended, revised and/or supplemented as follows:

SECTION 1. The Municipal Code of the Borough of Bay Head is hereby amended, revised and supplemented so as to establish Chapter 82 (new) entitled “Rules, Regulation, and Fees for Municipal Tennis Courts” as follows:

§82-1 Tennis/Pickleball Courts Rules and Regulations.

- (A) Courts are to be used for tennis/pickleball only; no other use is permitted. Roller-skating, rollerblading, skateboarding, and bicycle riding on the courts are prohibited at all times.
- (B) Tennis shoes and sneakers must be worn while on the courts.
- (C) Pets are prohibited from being on the courts at all times.

(D) Smoking, vaping, tobacco products, food and beverage are prohibited within the playing area.

(E) Privately instructed lessons are prohibited on Borough of Bay Head tennis/pickleball courts at all times.

§82-2 Fees.

Any person wishing to reserve use any Borough of Bay Head tennis/pickleball court shall be required to first register. The fees are as follows:

(A) Yearly membership for court reservation and programs:

Family Resident \$25.00.

Family Non-Resident \$75.00.

(B) Pickleball Clinic Fee \$20.00 - 30.00 per session.

(C) Pickleball Open Play \$10.00 - 20.00 per session.

(D) Tournaments \$50.00 - 100.00 per tournament.

(E) Round Robin \$15.00 - 25.00 per session.

(F) All reservation fees shall be for the calendar year and shall not be pro-rated.

Proof of residence shall be provided by NJ Driver's License, tax, water, or sewer bill, or 12-month lease, and may include any dependents residing in the home.

§82-3 Hours of Operation.

The Borough of Bay Head tennis/pickleball courts shall have an 8:00 a.m. start time and end at dusk. No use of the courts may begin before this start time.

§82-4 Violations and Penalties.

Any person who violates this chapter or fails to comply with any of its requirements shall, upon conviction thereof, be subject to the maximum fines and penalties established under N.J.S.A. 40:49-5 and as same may be amended from time to time.

SECTION 2. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed, but only to the extent of such inconsistency.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.


SECTION 4. The ordinance shall be published at least once in an official newspaper of the Borough of Bay Head at least ten (10) days prior to the time fixed for consideration of the final passage of the ordinance.

SECTION 5. This ordinance shall take effect after second reading and publication as required by law.


